90 DAY PARTS WARRANTY ON HARD PARTS ONLY, NO GASKETS, SEALS OR AIR SYSTEMS WARRANTIED. **NO LABOR.** EXTENDED WARRANTY TO 6M W/FLUID.
- **REFURB**
6 MONTH PARTS WARRANTY ON HARD PARTS ONLY, NO GASKETS, SEALS OR AIR SYSTEMS WARRANTIED. **NO LABOR.** EXTENDED WARRANTY TO 9M W/FLUID.
- **RECON**
12 MONTH PARTS WARRANTY, FIRST 6 MONTHS PARTS AND LABOR ON HARD PARTS, GASKETS, SEALS, BEARINGS EXC. NO AIR SYSTEM. PARTS ONLY AFTER 6 MONTHS
LABOR RATE WILL NOT EXCEED \$75.00 PER HOUR WITH A 10 HOUR MAXIMUM.
NO LABOR AFTER 6 MONTHS. EXTENDED WARRANTY TO 18M W/FLUID. **(6 MONTH P/L 12 MONTH PARTS ONLY)**
- **REBUILD/REMAN**
12 MONTH PARTS AND LABOR WARRANTY, INCLUDES SEALS, AIR SYSTEMS AND SUPPLIED ELECTRICAL. LABOR RATE WILL NOT EXCEED \$75.00 PER HOUR WITH A 10 HOUR MAXIMUM.
EXTENDED WARRANTY 18M PARTS AND LABOR WARRANTY W/FLUID. (WATCH FOR SPECIALS ON EXTENDED WARRANTY)
- **ELECTRICAL ITEMS ON AUTOMATIC/AUTO MANUAL/MANUAL**
NO WARRANTY ON ELECTRICAL ITEMS. ALL ELECTRICAL ITEMS THAT ARE LEFT ON THE UNIT ARE FOR CONVENIENCE ONLY, HOLST TRUCK RECOMENDS ALL ELECTRONICS BE REPLACED. DAMAGE DUE TO ELECTRICAL FAILURE WILL RESULT IN AN AUTOMATIC WARRANTY VOID.

ALL WARRANTY CLAIMS MUST SUBMITTED IN WRITING WITHING THE WARRANTY PERIOD STATED ABOVE. NO WARRANTY OR COST RE-EMBURSMENT IF NOT APPROVED BY HOLST TRUCK & AUTO WRECKING. ALL CLAIMS ARE SUBJECT TO DECLINE. ALL CLAIMS MUST BE INSPECTED BY HOLST TRUCK & AUTO WRECKING AT 10209 N YELLOWSTONE HWY, UCON, ID 83454 OR BY A LEAZON OR REPRESENTATIVE APPROVED BY HOLST TRUCK & AUTO WRECKING. HOLST TRUCK PARTS WILL ACCEPT NO RESPONSIBILITY FOR INPROPER INSTALLATION, ABUSE, NEGLECT OR NON FACTORY ACCESSORIES. NO WARRANTY CLAIM MAY EXCEED THE COSTS OF THE ORIGINAL INVOICE. NO HAZARD WARRANTY, TOWING, DOWN TIME, HOTEL/ACCOMIDATIONS ARE COVERED. IF WARRANTY CLAIM IS APPROVED, STANDARD NON EXPEDITED FREIGHT WILL BE COVERED ON REMAN, REBUILT AND RECON UNITS. NO FREIGHT RE-EMBURSMENT ON REFUB AND TAKE OUTS UNITS. HOLST TRUCK PARTS RESURVES THE RIGHT TO EXCHANGE, REIMBURSE OR REPAIR ANY OR ALL WARRANTY CLAIMS. ALL FLUIDS MUST BE CHANGED AT MANUFACTURE INTERVALS AND WITH APPROVED OILS.

IF DOWN TIME IS AND ISSUE, CUSTOMER MAY PURCHASE A REPLACEMENT TRANSMISSION WHILE A WARRANTY CLAIM IS BEING PROCESSED. IF THE WARRANTY IS APPROVED REFUNDS WILL BE GIVEN AS STATED ABOVE.
